- Each of Georgia's 159 counties has an Emergency Coordinator.



ARES LEVELS

- Level 1 ARES
- Level 2 ARES (Deployable)
- Level 3 ARES (EC, AEC, and EMA Staff)
- All ARES members are expected to establish and complete ARES Training as outlined in the <u>ARRL ARES Standardized Training Task Book</u>. These task cover basic activities/principles that you as a radio operator must become proficient in performing.
- (No Worries, We will help you gain the experience you need!)



FEMA Training

- Our operations must comply with the National Incident Management System (NIMS). We operate under the Incident Command System (ICS) when activated.
- The Department of Homeland Security (DHS) requires all volunteers, including Amateur Radio operators to be certificated in at least IS 100, IS 200, IS 700 and IS 800 course material.
- For non-governmental employees and others without access to classroom instruction, these courses are available as on-line independent-study courses that are free of charge.

ARES Commitment

To Remain in an "Active" Status in Cherokee ARES, requires a small commitment from you.

Our Served Agency must have confidence we are prepared to support our community when called upon.

Requirements:

- Attends minimum of 2 Monday Night Cherokee ARES/SKYWARN Nets per Quarter
- Attends minimum of 2 Tuesday Night NW GA District ARES Nets per Quarter
- Attends minimum of 1 Drill/ARES Exercise per year. (Field-Day, GA Death Race, GA Jewel, GA SET, or Real-World Activation)


*** Preference is for you to attend as many of these exercises that you can, but we understand you must balance your personal life as well...



Net Communications

Ground Rules for participating during a Directed / Formal Net:

- During a Directed Net, Only use the frequency for official traffic
- **LISTEN**. The **Net Control Station** (NCS) will provide instructions on how to check into the net and what is expected during net activities
- Follow the net protocol established by the NCS
- Report in to the NCS promptly when you arrive at your station
- If you need to talk to someone directly, ask the NCS for permission
- Answer promptly when called by the NCS
- If you leave your station during a Directed Net, Inform NCS
- Do not utilize Q-Signals, 10 Codes, etc. speak normally in clear language. For Example, do not use *QSL* to Acknowledge a message, instead use the word, 'Acknowledge-Over'. This is important as we will be working with many different Served Agencies and the communications must be fully understood by all parties. (Including National Weather Service, MARS, American Red Cross, Georgia Emergency Management Agency, Local County and City agencies, etc.)



Common Prowords

Below is a list of Common Prowords we shall utilize. Emergency Communications requires clearly spoken language to avoid any confusion or miss-interpretation of meaning:

- CORRECT / WRONG. The proword CORRECT means "what you transmitted is correct". The opposite is WRONG.
- NEGATIVE / AFFIRMATIVE. The proword NEGATIVE means "No". The Opposite "AFFIRMATIVE" meaning "Yes".
- SAY AGAIN. The proword SAY AGAIN is used to request a repetition of something that was transmitted. The Proword I SAY AGAIN means I am about to restate something I have already transmitted.
- WAIT and WAITOUT. The proword WAIT is used when a pause is required and will last less than five seconds. Wait should not be over-used; you may simply pause a second or two without saying it. WAIT OUT means I must pause for longer than five seconds before continuing/responding, in the meantime other stations can transmit as normal.
- WILCO. The proword WILCO is a contraction of the phrase "will comply". It is used in response to a request or tasking and means that you understand the tasking and agree to accomplish the task. Because it implies you understand the request, it is never used with the proword ROGER as that would be redundant.
- OVER. The proword OVER means, I have finished my transmission, go ahead and transmit.
- OUT. The proword OUT means, I have concluded my transmission, no reply is expected.
- ROGER. The proword ROGER means, "I have received the information by you" without indicating approval or disapproval, agreement or disagreement. Do not confuse ROGER for WILCO.
- THIS IS. The proword THIS IS means, "The current transmission is from the station who's call sign follows." This proword can be omitted after communications are established.
- THIS IS A DIRECTED NET. This proword THIS IS A DIRECTED NET, spoken by NET Control, means that until further notice the NET is directed. This means that all stations need permission of NET CONTROL to call other stations. The Opposite is FREE NET. In a FREE NET, any station may call any other station without NCS Permission.



Passing Formal Traffic

- During an emergency, precise message handling is critical. It is important to record and pass on messages quickly and accurately
- Keep Transmissions to a minimum.
- Avoid Spreading Rumours Don't expand or speculate on what you may hear on the air or while in the presence of officials.
- All "official messages" should be written and signed by the originator.
- Send formal traffic EXACTLY as you received it. Don't correct it, change it, elaborate, or try to interpret it. Ask for clarification before Sending
- Copy it as you received it. Send it as you were requested.
- Use the right mode and band to suit the need.



Weekly Training NETS

- We are fortunate to have various local, state, and regional weekly nets available to our teams.
- To help prioritize the nets for the Cherokee ARES teams, we are requesting that we participate, as time allows, on the Cherokee ARES, Cherokee CARS, and NW GA ARES weekly nets.
- By keeping focus on our County and District we are better able to mutually support one another during an activation or incident.

Activation







Activation of Cherokee ARES

- CC-ARES activations for the EOC are initiated by the EOC Staff by notifying the EC or designated AEC(s). An email is sent via e-mail distribution using Cherokee ARES Groups.IO
- Typical activation will be through the emergency net on the designated repeaters.
 - CC-ARES members should monitor WX4AUX/WA4EOC/KG4VUB during severe weather or local major events for the standup of SKYWARN or Informal nets.
 - If capable also monitor KC4AQS for reporting requests and real-time information provided from National Weather Center out of Peachtree City GA.
- Email notification to Cherokee ARES members and teams will attempted to be sent through the Cherokee ARES Groups.IO by the EC or AEC(s).
- Last mile, if required, voice-calls and or test messages sent to your cell phone on file with Cherokee ARES will be used.



Activation Procedures

- 1. Establish an ICS-214 Activity Log. Record your activation date/time, any major significant event that occurs, and when mission is over, record the deactivation date/time.
- 2. If instructed by your chain of command to deploy, report your departure to the mobilization site and arrival. On demobilization, record the time your leave the area and report to your home station.
 - This is important for accountability.
 - Report these major milestones to your leadership via Voice, Text, Email, any method you can for near real-time tracking.
- 3. Follow the deployment and demobilization instructions you are provided.
- 4. Upon completing the mission, develop an After-Action Report.
 - Identifying areas to Improve as well as Sustain.
 - We must take advantage of every opportunity to identify areas to improve before next activation.
 - Submit that report to your Emergency Coordinator and team leader if assigned.






SKYWARN

- The majority of SKYWARN activity in the State of Georgia is coordinated through the NWS Peachtree City (NWS-PTC) office in Peachtree City.
- The amateur station **WX4PTC** is located at the National Weather Service office in Peachtree City, GA.
- You will find during severe weather, <u>WX4PTC</u> may link to one of our local Repeaters KC4AQS and/or W4DOC.
- When this occurs listen carefully to the information **WX4PTC** is broadcasting or requesting, while also monitoring our local Cherokee County SKYWARN net.
- Do Not interrupt a SKYWARN net or provide information that does not meet the criteria that WX4PTC is requesting. Follow the guidance of Net Control. Many times, just listening is all you need to do and then share on our own Cherokee ARES SKYWARN net.
- WX4PTC is looking for critical ground truth to overlay with additional reports or radar indicated activity, in order to adjust the National Weather Service alerts for the affected area.







Frequencies

- It is requested that you load the frequencies contained in our ICS-217 Communications Availability Worksheet in your radio, prior to an incident/activation, so that you are prepared at time of activation.
- We have various code-plugs available for download, or we can assist you, if necessary, load your radio.
- The ICS-217 has frequencies for Cherokee ARES (UHF, VHF), GA ARES HF, WINLINK, and NW GA District and Surrounding Counties.
 - Your Primary Channel for Cherokee County ARES will become <u>WX4AUX</u> 145.190 PL 107.2
 Training Sessions will begin testing this repeater. In coming weeks we will make the switch....
 - Your Alternate Channel for Cherokee County ARES are <u>WA4EOC</u>.
 - Your 3rd Alternate Channel for Cherokee County ARES is <u>KG4VUB</u>.
 - The remaining Channels will be used as needed.
 - DSTAR- Will not be used for NET, but a tool to communicate outside region (REF030B, etc)

Computer Applications

- 1. Winlink. Winlink is used to send emails and various forms between Ham Operators. All ARES members are requested to install and configure Winlink, as a minimum using "Telnet"/Internet to send and receive messages.
 - If you can connect your computer to your radio (Advanced Task), then you can send and receive important messages without any dependance of the internet. This will become a valuable method of communicating when we have an internet disruption or if you are deployed to a location with no Internet/Cell service. (AKA one of our annual events in the mountains of North Georgia).
- 2. D-RATS is a tool for real-time Instant Messaging between Ham Operators. All ARES members are requested to install and configure Winlink, as a minimum using "Telnet"/Internet to send and receive messages. There is as Advanced Task where if you have a DSTAR Radio or TNC, you can send/receive D-RATS messages without the reliance of the Internet.
- 3. APRS. APRS will be used to provide quick updates as needed via RF/Internet

** (FLDIGI at this time will not be adopted by Cherokee due to complexity & message delivery instabilty)

RACES- the Radio Amateur Civil Emergency Service

- Founded in 1952, the Radio Amateur Civil Emergency Service (RACES) is a public service provided by a reserve (volunteer) communications unit within government agencies in times of extraordinary need. During periods of RACES activation, certified unpaid personnel are called upon to perform many tasks for the government agencies they serve. Although the exact nature of each activation will be different, the common thread is communications.
- RACES, almost never starts before an emergency and is active only during the emergency and during the
 immediate aftermath if government emergency management offices need communications support. RACES is
 normally shut down shortly after the emergency has cleared.
- In the event that the President invokes his War Emergency Powers, amateurs involved with RACES might be limited to certain specific frequencies (while all other amateur operation could be silenced).
- RACES Operators must be registered with the local emergency management agency



ARES and RACES Comparison

Activation	Operations can take place in advance of an emergency, during the emergency, and an indefinite time after the emergency has cleared.	Except for drills, starts as a result of an emergency, active during the emergency, and deactivated shortly after the emergency has cleared.
Operator Registration	Does not have to be registered. Suggested to register with local ARES Emergency Coordinator.	Must be registered with the local emergency management agency.
Communications	Limited only by standard Amateur Radio rules.	Restricted to/from other RACES stations.
Messages	Limited only by standard Amateur Radio rules. Example: Health and Welfare would be allowed in ARES, but may not be allowed in RACES.	Communications must be specifically authorized by the civil defense organization for the area served. Generally limited to public safety, immediate safety of life of individuals, the immediate protection of property, maintenance of law and order, alleviation of human suffering and need.
Drills	Limited only by standard Amateur Radio rules.	Cannot exceed a total time of one hour per week. With proper authorization, drills may be conducted twice in a calendar year for a period not to exceed 72 hours.
Served Agencies	Emergency management organizations as well as other non-profit organizations.	Limited to emergency management organizations.
Restricted Operations	May be restricted from operating in some communication emergencies.	May be allowed to operate in a communication emergency when other amateur radio stations are restricted from doing so.



 - Bring snacks/etc, however EOC will take care of all personnel that activate
- Volunteer to join the EOC Team- Contact W1JKU, KJ4UC, or KO4IFY
- Current EOC Team: W1JKU, KJ4UC, KO4IFY, KD4KHO, KO4PWB, KO4UQF, WX4WCS, K9APD

ARES and EOC Access

- Cherokee County has given W1JKU Access to use the facility at any time.
- We will operate as a minimum 1 Net per month from the EOC to ensure all equipment remains operational.

Ground Rules/ General Orders

- 1. You will be instructed on where to report when you are requested to deploy to the EOC. When you arrive, you may be issued a visitor badge if required by EMA staff.
- 2. You will dress professionally when reporting to the EOC.
- 3. You will act professionally at all times and treat others with utmost respect.
- 4. If there is a misunderstanding or disagreement with other members located at EMA, notify your chain of command, and DO NOT engage in divisive discussions, arguments, etc.
- 5. Do Not bring visitors or guest to the EOC, they are not authorized at this facility.
- 6. Keep your voice down, so that you are not distracting anyone else at the EOC.
- 7. All radios will be run with headsets or speakers on low volume so that others do not hear our traffic and we become a distraction versus an asset.
- 8. Zero Tolerance for alcohol or weapons at the EOC. Failure to comply may result in an extended stay behind the secure fence and will result in termination from ARES and Cherokee County Amateur Radio society.
- 9. Plan on bringing snacks, lunch, and a water bottle. If the deployment is extended, the EOC will provide food and have ample water supply.
- 10. During an activation, do not park in front of the EMA main doors. Park on the side of the building or across the street as the EMA will be very busy. Enter through the EMA front door where you will be admitted. You will take the Elevator to the ground floor and will be given directions to the EOC room if you are unfamiliar.

Activation Instructions

- 1. Upon arriving, you will immediately sign in with the ARES assigned lead and ensure an ICS-214 is established. The ICS-214 will record all ARES members arrival and departure from the facility, and all critical events.
- 2. If you are required to unlock the ESF2 Radio Room, return key to key box and lock the key box immediately after gaining access to the ESF2 Radio room.
- 3. Fill out EOC Log recording time you arrived at the EOC. The clipboard is on the wall above ARES file-cabinet.
- 4. Station Requirements:
 - a. ID5100 Channel A will be configured for the Primary ARES Frequency, WX4AUX/WA4EOC Repeater.
 - b. ID5100 Channel B will be configured for the Alternate ARES Frequency, WA4EOC/KG4VUB Repeater.
 - c. Kenwood TMS700 Channel A will be used for APRS, or Winlink as needed.
 - d. Kenwood TMS700 Channel B will be configured for the KC4AQS Repeater.
 - e. Yaesu FT950 will be configured for 3.975 or designed HF Frequency.
 - f. DRATS will be started on both computers:
 - i. Computer 1- (PS-EMA-6QHFZB3)
 - ii. Computer 2- (PS-EMA-72DL9N2)
 - g. Winlink (Internet/VHF) will be started on Computer 1. The Internet will be used as the primary mode of communication if the Internet is functioning, else VARA-FM or Packet will be used.

 The computer userid and password can be located on the front of the monitor.
 - h. Winlink (HF) will be started on Computer 2 if needed.
 - i. WEBEOC will be started on both Computer 1 and Computer 2 to ensure we can monitor and report as needed. An ICS-214 will be established for the activated Incident. Significant Events will be logged as necessary. See additional details in this guide for Reporting Requirements for more details.
 - The Cert Radio will be enabled and monitored during activations, and we will remain prepared to communicate with CERT members located at Lake Arrowhead without using HAM Callsigns. We will use the Call-Sign 'Cherokee EOC' when communicating with Lake Arrowhead Cert.
- 5. Cherokee ARES members will not touch the top shelf over Computer 1, as this belongs to the Tornado Alerting System. This shelf will only be used by EMA Staff. Cherokee ARES will not touch the Power Supply labeled for the Tornado Alert System.

File Cabinet


The file cabinet to the right of Computer 1 is labeled and reserved for ARES Use Only.

- 2. Drawer #2 currently contains a few key headphone cables and miscellaneous parts.
- 3. Drawer #3 contains various blank forms including ICS-211, ICS-213, ICS-214, extra blank writing paper, Band Plan, Blank CCARES Rosters, Laminated ARES Preamble, and a Misc folder.








